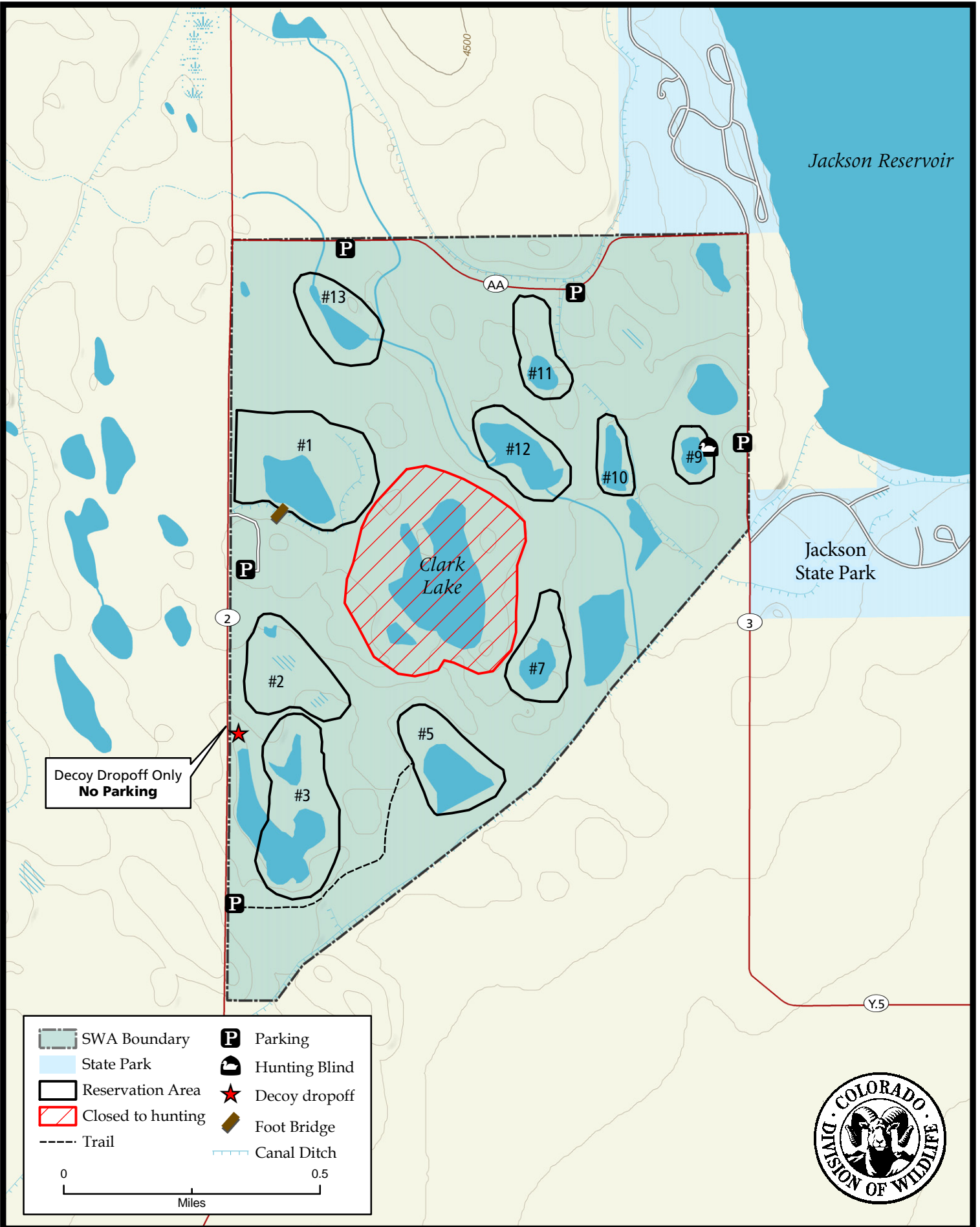


# Andrick Ponds State Wildlife Area

## Migratory Bird Hunting Areas

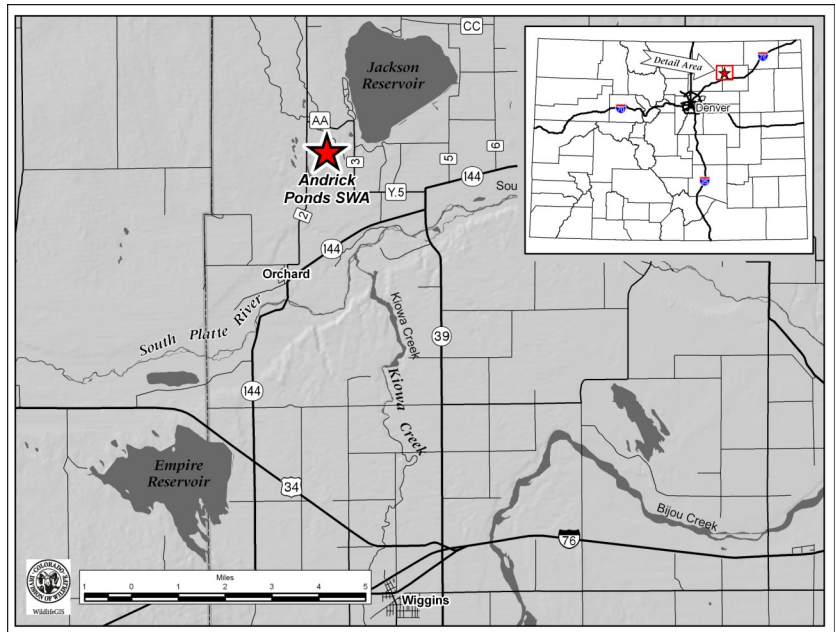


## Andrick Ponds SWA - Morgan County

From Interstate 76 at the Highway 39 exit (Exit 66), go 7.4 miles north on Highway 39 to Highway 144 and Morgan County Road (MCR) Y.5, then 1.5 miles west (left) on MCR Y.5. Turn North (right) on MCR3 for 1.5 miles to MCR AA. Go West (left) on MCR AA just before the entrance to Jackson Lake State Park and go 1 mile to MCR 2. Turn south (left) on MCR 2 for .54 miles to the parking entrance and parking area on the east (left) side of MCR 2. To access the south parking lot, continue south on MCR 2 one half mile to the parking lot on the east (left) side. The north parking lot provides access to Areas 1 and 2, and the south parking lot provides access to Areas 3, 4 and 5.

Hunting: Waterfowl



**#901.A:** Reservations may be made by calling 1-800-846-9453. Reservations are not accepted more than 14 days in advance of the hunt date, nor after 12:00 noon on the day before the hunt date, or Friday at 12:00 noon for Sundays and holidays falling on Monday. Hunters who wish to cancel a reservation must do so no later than 12:00 noon on the day before the hunt date. Failure to hunt a reserved area without prior cancellation, or follow check station procedures, may cause forfeiture of the privilege to make reservations for the remainder of the hunting season. Hunters are limited to a maximum of one reservation per hunt date and one reservation per phone call. Reservations are not transferable. The individual named on the reservation must be at the property on the day of the hunt and be a licensed hunter for the species to be hunted.

1. Small Game - Small game hunting is restricted to December and January, on Sundays only. December 5, 19 and January 16 will be limited to youth/mentor small game hunting. On these three dates, at least one member of the hunting party must be a youth under 18 years old, and hunters 15 years old or younger, must be accompanied by a mentor. Three hunting areas will be established for small game hunting and named the northwest area, the southwest area, and the east area. All small game reservations for each area will be awarded by lottery. To enter the lottery, hunters must send a post card to: Attention Andrick Ponds Reservations, Brush Service Center, 122 East Edison Ave., Brush, CO 80723. Cards must be postmarked by September 30, and include the hunter's name, address, CID number, and preferred hunting areas and dates. Successful applicants will be notified by October 21. Hunters can apply for no more than 1 hunt area each day, but can list multiple dates on 1 postcard.

2. Migratory Bird - Migratory bird hunting is only allowed on Saturdays, Wednesdays, and legal holidays from December 1 through the close of the dark goose season. Hunting areas will remain the same as they were from September 1 through November 30, and reservations will continue to be taken at 1-800-846-9453, following normal reservations procedures.

### Restrictions:

- Camping is prohibited.
- Fires are prohibited.
- Discharge of firearms or bows is prohibited, except when hunting.
- Hunting is prohibited with center-fire rifles.
- Access allowed only through designated parking areas.
- Public access is restricted to foot traffic only.
- Dog training is prohibited.

- Year-round public access is limited to Saturday, Sunday, Wednesday, and legal holidays. During these days, public access is prohibited from 9:00 pm to 3:00 am. Night hunting is prohibited.
- From the first Saturday prior to Memorial Day holiday through August 31, access is limited to wildlife observation only with access limited to areas posted at the property. Dogs are prohibited during this period.
- From September 1 through the Friday prior to Memorial Day holiday only hunting is permitted.
- From September 1 through the November 30 all public use is prohibited, except for migratory bird hunting within designated hunting areas.
- From December 1 through the end of the regular goose season, hunting is permitted for migratory birds and small game. During this time period, hunt days will be established as small game hunting or migratory bird hunting only to minimize conflicts. Hunters may refer to the small game or waterfowl brochure to find which dates are designated small game hunting only and which dates are designated migratory bird hunting only.
- From the Thursday before September 1 through the end of the dark goose season, scouting is permitted only on Thursdays that are not open to hunting within and immediately prior to established waterfowl seasons. Scouting will be permitted from 10:00 am until 2:00 pm with a reservation confirmation number or letter issued by the Division, and all persons scouting must check in and check out at the check station. During scouting dates, firearms and dogs are prohibited.
- From the end of the dark goose season through the Friday prior to Memorial Day holiday only spring turkey hunting permitted.
- Hunting is prohibited on Clark Lake.
- Hunting on this property is by reservation only. Reservations may be made in accordance with #901.A of these regulations. No more than four hunters are allowed in each area at any one time.
- From September 1 through the end of the regular goose season reservations are limited to three per hunter annually.
- Hunters must follow check-in and check-out procedures as posted at the property.
