SPRING TURKEY APPLICATION DEADLINE

The deadline for customers to apply for a spring turkey license is February 9th, 2012. Customers applying for the spring turkey license can purchase the required Habitat Stamp from your terminals. Just use product code 060 "Colorado Habitat Stamp Validation" in the **2012 license year option**.

Please be aware of any messages on your ACH Report, particularly with regard to property insurance and surety bond renewals. All Annual Licenses, i.e. Fishing, Small Game, Furbearer, Combo fishing and hunting, and Colorado State Waterfowl stamps for 2012 will go on sale **MARCH 15, 2012**. However, customers may still purchase a 2011 Annual License which is valid until March 31, 2012.
